Corporate Sales

Since the last report I have sold two shirts and have \$24 to give to the Treasurer to deposit along with the remaining dues money the clerk should have at this meeting.

Called Bob Eggleton last Thursday and received art yesterday (Tuesday 11/12) for the 97 shirts. Unless I somehow forget to carry it out the door with me, I am displaying it here for people to get a sneak preview.

On a side note, since I was asked to do the Team Arisia T-shirts as well, I am looking into getting the art for those from Kim by my deadline of December 1 as well.

I am working on getting back my previous Sales staff and adding to it to minimize the time I must spend personally manning it, particularly in light of my other hat.

I've thrown some ideas to Joel regarding corporate recruitment and the potential role of Sales in it. One thing that's always a problem for Sales is knowing who is a corporate customer, for the merchandise discount. (20% for those who don't know, except where specifically excluded.) The idea of a ribbon, pin, badge sticker, or special badge color is ideal for anybody at Sales to know corporate members on sight. That way if corporate memberships are sold at a "club table," new members will be recognized by sales, and the discount can

be used as an incentive (for what it's worth) by recruiting.

I'd like to make a motion now regarding disposition of old shirts:

MOVED to sell all Arisia merchandise T-shirts for years prior to 1996 at a price of \$2.00 each with no discounts, and sweatshirts at a price of \$5.00 each with no discounts, now through Arisia '97, and to donate any remaining at the end of Arisia '97 to any charitable organization serving the poor or homeless, such as Pine Street Inn or Salvation Army.

Motion ammended as friendly "That one of every T-shirt/sweatshirt be saved for historical purposes."
