GOH shipping, and add \$400 to Contingency, \$500 to Thursday night dinner, \$100 to Tech - Sound. Main motion PASSES many to a couple.

A14: *M* to set as policy new Arisia convention membership rates.

MSPU (Kovalcik, chorus) to go into Committee of the Whole results (C. Huff, chorus) in:

- Raise Student Rate \$5 to \$30
- Raise Year-ahead \$10 to \$40
- Raise Early Pre-reg \$5 to \$45
- Raise Late Pre-reg \$5 to \$55
- Raise At the Door/Babysitting rate \$5 to \$65

The chair *splits the question* to address Late Pre-reg and Atthe-door separately. *MS (Murphy, Reese) to overrule the chair FAILS 12 to 16.* This results in *MP (35-6) to:*

- Raise Student Rate \$5 to \$30
- Raise Year-ahead \$10 to \$40
