The meeting was called to order by Kris Snyder at 7:55 PM at the NESFA Clubhouse, 504 Medford St., Somerville, MA.

A'16 (Kris "Nchanter" Snyder):

No report.

A'16 Treasurer (Rick Kovalcik):

Still working on it (coming up with total for the various areas; we already have totals for income and expense).

A'17 (Anna Bradley):

Tom Traina is working on the books.

A'17 Treasurer (Tom Traina):

Not present; no report.

A'18 (Jaime Garmendia):

We asked the hotel search committee to look into space for the Conchair Special Project. The Aloft declined. We are looking into other options.

We just had our first Div Head meeting. Thanks to people for attending.

The Convention Committee has adopted some guidelines for the use of Slack which the Corporation might wish to adopt at a later day.

#### A'18 Treasurer (Ellie Younger):

We are spending \$200 for advertising in WisCon publications. We are planning upcoming WisCon and Readercon Parties. I'm behind on working on the treasury stuff.

#### A'19 Chair (Daniel Eareckson):

We are going to have a con. I am working on drafting a bunch of emails.

#### Budget (Benjamin Levy):

We should have a Corporate Budget available for publication in the next Mentor and voting on at the June meeting. [See http://corp.arisia.org/treasurer or http://tinyurl.com/2017-2018-arisia-corp-budget.]

#### CIC (Rick Kovalcik):

Lisa found a few potential other storage place. There was nothing cheaper that was acceptable or better.

Motion out of committee to authorize Ben Levy, after consulting with the Eboard, to extend the current lease for three years and sign a lease for the new space of about 300 square feet to end the same time at the rates discussed. Passes.

Corporate Welcoming Committee (Daniel Eareckson):

Hello. Welcome. The Corporate website has some information.

#### Grants Committee (Cody Mattes):

The Grants Committee and Eboard both voted to recommend fund the request from the Locus Science Fiction Foundation for \$2,800 in funding for the annual Local Awards. The full text of the grant request can be found at http://tinyurl.com/2016-arisia-locus-grant. There was some discussion about whether we should tell them this was the (third and) last time we would be funding them.

Moved to amend the motion to include "It is the sense of the Arisia Corporation that since this is the third time we have funded these awards we will not look favorably on further requests to fund these awards but would consider other requests from them for other things and the Grant Committee is instructed to inform them of this." Motion to amend passes 21 to 9 with 1 abstention. Main motion passes 27 to 4 with 2 abstentions.

Hotel Search Committee (Kris Snyder):

Nothing to report.

Honors Committee (Mike Sprague for Anna Bradley):

No report.

IT Committee (Peter Olszowka):

No report.

Logo Committee (Conor Walsh):

I have been very busy at work, hopefully that is over now and we should do stuff.

Long Range Planning Committee (Conor Walsh):

I have been very busy at work, hopefully that is over now and we should do stuff.

Relaxacon Committee (Ellie Younger):

We have 26 rooms reserved and the hotel still has vacancies. The meal survey will be coming out in the next week or so; please buy your membership so we can ask you questions! Thanks to everyone who has volunteered to help with meals, we're still looking for a few more helpers: we can plan the meals for you and just need help making sure all the food gets put out. Ben reports we now have 31 adult memberships which include some teens. People should also buy their memberships since we know there are more people than that attending.

Student Contests Committee (Kris Pelletier):

We are working on updating the school list that we have and thinking about updated budget numbers.

Old Business:

Moved to take the motion to amend 2.4(j) off the table (Levy, Kovalcik). Passes.

Motion to amend Bylaws 2.4(j) to insert the words "including their name" after Convention Chair

(j) The announcement of the appointment by the Eboard of a Convention Chair **including their name**, and the subsequent vote of approval by the membership under Section 6.2 (a).

Nchanter makes the same speech she did last time about this being an oversight.

Conor questions the word of the start of that clause. It was pointed out that we aren't changing the start.

Passes close to unanimously with a couple of abstentions. [The piece of paper with the vote totals was lost or at least currently misplaced; 2/3 is required to pass a bylaws amendment.]

Moved to take the motion to amend 6.7(b) off the table (Garmendia, Kovalcik). Passes.

Motion to amend Bylaws 6.7(b) to add the words "subject to the approval of the Executive Board" at the end.

- 6.7 Assistant Convention Chairperson(s)
- (a) Each Convention Chairperson shall serve as the ex-officio Assistant Convention Chairperson for the Convention immediately prior to the Convention they are chairing, provided they are appointed and confirmed before the close of said prior Convention. The Convention Chairperson shall assign duties to the ex-officio Assistant Convention Chairperson consistent with preparing them for their subsequent term as a Convention Chairperson.
- (b) This section does not limit the authority of the Convention Chairperson to appoint additional Assistant Convention Chairperson(s) subject to the approval of the Executive Board.

At this point Kris Snyder handed the running of the meeting to Jaime Garmendia.

There was much discussion along two main lines: we need more continuity vs. this is micromanaging and what happens if the Eboard doesn't act.

Moved to amend by deleting the words "subject to the approval of the Executive Board" from the original motion and add a new clause:

6.7 (c) The Conchair will submit the names of any additional Convention Chairpersons to the Executive Board. If the Executive Board approves the appointments or takes no action within two (2) weeks, the appointments are confirmed.

There was discussion along the lines of this is in keeping with the way grants are dealt with and less likely to lead to long delay.

Amendment was called. The amendment to the Bylaws amendment passed 24 to 4 with 5 abstentions.

There was still more discussion about the main (now amended motion) along the original lines.

There was a request for a secret ballot so one was held.

The bylaws amendment fails. Secret ballot.

Fails 13 to 19 with one abstention.

At this point Kris Snyder told over running the meeting again.

#### New Business:

Motion to authorize the Eboard to negotiate an agreement for Relaxacon 2018 with existing venue (Kovalcik, Garmendia). Passes many to 1 with some abstentions.

The June Corporate meeting is 2:00 PM on Sunday June 18th at the Westin Boston Waterfront in Boston. Lisa Hertel agrees to take minutes as the Clerk, Rick Kovalcik, will hopefully be at a Worldcon76 San Jose Div Head meeting in California that weekend.

The July Corporate meeting is 2:00 PM on Sunday July 23rd at Rick Kovalcik's home in Newton with Corporate Cookout to follow.

Motion to have the August meeting on Thursday 24 August at 7:30 PM preferably at NESFA (Nchanter, Many Seconders). Passes.

#### Announcements:

There will be a Programming Brainstorm meeting on Sunday 25 June 2:00 PM at the Westin.

Meeting was adjourned at 10:00 PM. Minutes taken and submitted by Rick Kovalcik.
