About the Meeting

The next corporate meeting of Arisia, Inc. will be held on **Tuesday October 13, from 7-9pm** by Zoom teleconference. The link to the meeting will be distributed over the corp-announce email list in advance of the meeting.

The Executive Board has voted to allow members to participate in any meeting of members by remote participation, pursuant to section 16 of "An act to address challenges faced by municipalities and state authorities resulting from COVID-19". This session law, passed April 3, 2020, allows us to hold remote meetings and treat attendees at remote meetings as present, until 60 days after the current state of emergency is lifted.

The quorum for the October corporate meeting is **27**, based on 51% of the average attendance of the last three meetings $((63+50+45)/3\times0.51)=26.86)$.

Please submit proxies in advance by email to <u>corp-proxies@arisia.org</u> (a mailing list which will be seen by all subscribed corporate members) and CC the proxy holder. Please send all proxies for the October corporate meeting to <u>corp-proxies@arisia.org</u>, and CC the proxy holder.

At the October corporate meeting, the Eboard will be reporting on a number of actions under the Disciplinary Process. Please note that the IRs below come with the following **content warnings:** abuse of women....

- Arisia received a new report about a former Masquerade staffer who had been banned from attending for three years and from staffing permanently. This report detailed several additional incidents. After looking into the report, the Eboard has decided to make the previously issued attendance ban permanent.
- Arisia was made aware of numerous reports of abuse of women generally by an Arisia staff member and panelist. After looking into several of the reports, the Eboard has decided to permanently ban this person from attending Arisia events.
- The IRMC received a report concerning a series of emails between a corporate member and an Arisia Eboard member on the eboard mailing list. In these emails, the eboard member reacted to the anger of the corporate member by asking the corporate member not to email them again on the topic. While generally speaking, people should be able to set reasonable boundaries on what sort of private email they want to receive, when an

eboard member does so on the eboard mailing list, it prevents access to the eboard by members of the Arisia corporation and community. Given that Arisia does not have a specifically spelled-out policy on this, and that the eboard member has recognized the problem with her responses, the IRMC recommended that a warning be given. The IRMC also recommended that Arisia consider instituting a more specific written policy that will make it clear what is and is not appropriate in the future. The Eboard voted to accept this recommendation. This incident pertains only to the email thread in question, and additional issues around the publication of the incident in August are being handled separately.

Eboard report:

President's report:

Treasurer's report:

To join at this meeting is \$24, and due to the state ruling, this online meeting will count as your first attended meeting.

Committee Reports

Anti-Racism:

The anti-racism committee met on August 15. We do not have any proposals yet to bring before the corporate membership. Ilene has resigned as a member of the committee. Vivian is stepping down as co-chair, but will remain a committee member. We are actively seeking new members: white people who have begun taking the time to self-educate on these topics, and/or people of color who are willing to work alongside white people as we do this work.

Corporate Inventory Control:

Committee will wait until after official announcement of whether Arisia 2021 will be virtual to contact landlord regarding the plugging in of fridges.

Incident Review and Management:

The IRMC did not have incidents to report out at this meeting. The IRMC is always happy to take applications for volunteers. Volunteers average 2-5 hours/week of work. Thanks to Will McMain for supplying the following data:

Mission Statement:

The group meant recently to discuss splitting things into 2: a mission statement and a diversity statement to reflect comments that have been received. The statement will be posted to the Corporate list as early as the week of September 14, 2020.

Arisia 2021:

Two new divisions have been created; Access and Remote Conferencing. Justin du Coeur has been appointed to Remote Conferencing division head.

There is a meeting upcoming between the Hotel division head, Eboard president and representatives of the hotel to determine whether Arisia 2021 will be virtual. Guests of Honor have been notified of this.

Old Business:

MOTION [by Conor Walsh] to designate any money taken in from the Arisia 2021 \$75 membership rate not used to pay for scholarships to Arisia 2021 be donated to Violence in Boston.

Conor Walsh: UNTABLE motion. Suggests designtating at least 1 group that the Corporation supports in advance of A'2021. Suggests local groups working to end police brutality against people of color, including MA Bail Fund, ViB, Comics in Color, FIYAH. Would like to see this not limited to science fiction/fantastic/speculative fiction conventions/communities.

Open discussion: concerns regarding spending money before the Con is held, considering cost of putting on a virtual convention.

Phi: The point of a budget is that we can spend money in the budget regardless of whether the income has happened yet. It is possible that this will be the difference between the convention being a surplus or not. Arisia 2020 made enough money that we will not go under with the possible size of shortfall this year.

Open discussion: costs for additional Con expenses, such as closed captioning for live streams is not calculated. Belief that people are more likely to give directly to Con scholarships instead. Recreation of Jeans Fund (set amount of money goes to a local cause).

Clarification: donation funds would be drawn only from the \$75 memberships that aren't used to pay for convention scholarships.

Open discussion: there is no 'blizzard' or rainy day fund for Arisia; funding for Access is necessary; funding for staff needs to participate in Con are necessary; funding for supporting people of color in fandom and beyond is also necessary.

MOTION to call the question PASS 46 to 2

Phi: Ballots are cast using an online system with vote tokens emailed by Phi to all current members prior to the elections. Ballots are secret by nature of the online system. The IRMC reviews active incident reports against nominees in advance of voting and will have a disclosure conversation as we go along.

Jaime: Once nominations are done IR will go over the list of IR's and will do disclosure's as we go along.

Vivian: Does not line up with what was planned.

(In brief, IRMC had one procedure planned, election meetings have been practicing another. We were left at an in-between point where a partial IR disclosure had happened.) EJ: What do do about statements that may require content warnings?

Phi: Generally if someone has a content warning about anything that they should state that, let people turn sound off and then notify them when they are done. Can be in chat.

PRESIDENT VOTE: No further nominations stated

Gail: What are your thoughts personally about how IRs against the eboard have been handled?

Phi: IRs against the eboard have involved policy issues, have involved safety issues. People who handle the IRs should be separate from the people in power. We recently forgot that notification of the membership of IRs does not have to happen in Mentor but can happen in other means. An IR against an Eboard member is going to have recusals and have notification issues. Small concrete steps that can be taken and with enough we can move in the right direction.

Vivian: If you are elected to the eboard what will your role be on the con-chair team?

Phi: Have been involved in the con-chair team a lot and hope to continue to do so. A little concerned about that in conjunction with previous questions and give more levers of power to others.

COMMITTEE OF THE WHOLE to dispense with procedure and address partially-disclosed IR

Jodie: Received notification of IR last night. It's too vague to respond to, don't know what it might refer to.

MPA: Apologized for awkward disclosure, wanted to make sure people knew this was not about a recent Facebook situation.

Vivian: We all screw up. MPA disclosed from a few hours ago. MPA is running for member at large. (discussion of perceived conflict of interest)

EXIT COMMITTEE OF THE WHOLE VICE PRESIDENT VOTE: No further nominations stated

Vivian: How will you be involved in the Con-chair team?

MikeS: I will continue to be involved. The virtual state of the current convention has given me the cycles to do so.

(unknown): How would you deal with Eboard IRs?

MikeS: Eboard member, like an IRMC member, would be suspended on activities until resolved issue, when would resume duties or deal with consequences of decision. (paraphrased)

[At about this point in the Zoom chat, things became distracting with threads of conversation not related to what was going on in the audiovisual Zoom session. Gail and others made suggestions about how to handle this in future--see Corporate list email thread.] [voting for vice president]

TREASURER VOTE: No further nominations Vivian: How do you feel you would be involved in the con-chair planning? Kris: Am not involved, will continue to not be

involved.

Gail: What are your thoughts personally about IRs against the eboard?

Kris: To evaluate each IR as it comes in and use a general guideline and having consistency in when they would be removed from IR or Eboard would vary. Concern re using zero tolerance.

MPA: States interest in treasurer position for future reference [Voting for treasurer]

CLERK VOTE:

Pygment: Tell us about your role in dealing with intersectionalities? (paraphrased)
Etana: Working with the anti-racism committee and to work as Arisia grows, to recognize more of the populations involved in the convention. Hope more people will come forward and add to the positive work.

Alan: Thoughts regarding the resignation of the previous clerk. The clerk needs to be available

but also be able to draw personal own boundaries, and needs to have good safety boundaries.

Etana: Will reach out for mentorship and to keep in touch with people who can keep me accountable. Transformative justice.
