Officer and Committee Reports

Eboard report:

Voted to extend corporate membership grace period to October 31. This allows folks who haven't yet paid to re-join and keep voting rights. We have not yet purged the corporate mailing list based on lack of payment. That will happen as of 11/1/2020. Go to corp.arisia.org/join to renew online.

Voted to appoint Vivian Abraham as chair of Arisia 2022. This is subject to approval by the corporation. APPROVED

President's report:

Committee Reports

Anti-Racism:

The ARC met on 10/5/20 to solidify the three matrices of work that will be the immediate focus of the committee. The first is regarding Robert's Rules of Order and corporate meeting facilitation strategy. The second is education of the Corporation as a whole. This includes anti-bias training, de-escalation training for leadership (including moderators of online spaces), "Difficult Conversations" training, and the creation of an online book repository for Arisians. The third matrix is action, which is specifically targeting ways that we as a Corporation are upholding white supremacy and racism. Our first action will be to review the vendors used for Corporation business as well as Convention business. We want to divest from institutions and vendors that support white supremacy & racism and invest in vendors run by Black, indigenous, people of color, and non-white folk. Our next meeting will be in November via Zoom (date TBD).

Arisia 2020 Convention Treasurer

One of the Tech vendors needed a check reissued so books are still open; please get your Arisia 2020 receipts to the treasurer.

Corporate Inventory Control:

The committee has contacted the landlord of the storage facility that Arisia will not be hosting an in-person convention due to Covid-19. Thus, Arisia will not be plugging any additional equipment into power for testing/use this year. We need additional monies added to the Grant Fund in order to fund several grants requested prior to the C-19 pandemic. Should those grants be able to be funded, a temporary moratorium on issuing grants should be considered by the Corporation.

Incident Review and Management:

The IRMC successfully onboarded 2 new members this month, Claudia Mastroianni and Jodie Lawhorne.

- Arisia received a new report about a former Masquerade staffer who had been banned from attending for three years and from staffing permanently. This report detailed several additional incidents. After looking into the report, the Eboard has decided to make the previously issued attendance ban permanent.
- Arisia was made aware of numerous reports of abuse of women generally by an Arisia staff member and panelist. After looking into several of the reports, the Eboard has decided to permanently ban this person from attending Arisia events.
- The IRMC received a report • concerning a series of emails between a corporate member and an Arisia Eboard member on the eboard mailing list. In these emails, the eboard member reacted to the anger of the corporate member by asking the corporate member not to email them again on the topic. While generally speaking, people should be able to set reasonable boundaries on what sort of private email they want to receive, when an eboard member does so on the eboard mailing list, it prevents access to the eboard by members of

the Arisia corporation and community.

Given that Arisia does not have a specifically spelled-out policy on this, and that the eboard member has recognized the problem with her responses, the IRMC recommended that a warning be given. The IRMC also recommended that Arisia consider instituting a more specific written policy that will make it clear what is and is not appropriate in the future. The Eboard voted to accept this recommendation. This incident pertains only to the email thread in question, and additional issues around the publication of the incident in August are being handled separately.

Mission Statement:

Based on the feedback we received from members of the Eboard and our own committee, we determined that we needed to split the statement in two, consisting of a Mission Statement and a Diversity Statement. The reasoning for this is that to encompass the historical, current, as well as forward-looking purposes, values, and statements of intent of Arisia the convention and community is too much content to express in just 1-2 sentences.

- Mission "Arisia's core mission is to promote the celebration of science fiction, fantasy and speculative fiction, and to foster a diverse and actively inclusive community of fans."
- **Diversity Statement "Arisia** recognizes that it exists within a society which marginalizes many of its citizens. We also recognize the specific axes of marginalization that are historically present within the fandom community. Arisia strives to build a community that is inclusive of all races, genders, sexualities, religions, socioeconomic classes, disabilities, ages, and any other axis of marginalization. We recognize that this is an aspiration, not something we have achieved. Our goal as an organization is to arrive at a place where members of any and all marginalized groups can experience equal ownership of the convention and corporation."
