Officer and Committee Reports

Arisia, Inc. will set aside the greater of \$1000 or 50% of the profits of Arisia '21, the online convention, and subject to approval by a CPA, split that amount into equal donations to the Massachusetts Bail Fund and BLM Boston. Arisia will donate \$1000 initially by Jan 31, 2021, and any remaining amount by June 30, 2021. [PASSED UNANIMOUSLY]

Eboard report:

The Eboard voted to approve 0 dues waivers. We also voted to buy a laptop for Hannibal. After A'21, if Hannibal finds the laptop useful, it will be gifted to him. Otherwise, it will be returned to the Corporation. This will affect whether it is a convention or a corporate expense. For now this is TBD and we will update as we know more.

We voted to approve some IRMC actions, but notification of these did not go out in time for the 12 days notice. They will be reported out at the December meeting.

Our vote to extend the membership renewal deadline to October 31 (reported at the last meeting) enabled one member to renew and retain their voting rights.

President's report:

I set the date of the February meeting, with consideration for NESFA and BOSKONE events to Tuesday February 23 at 7pm. 25:1 PASSES

Question for Treasurer: \$46k is profit from A'20. A'20 books are not closed. Some trickling of dues & donations are in the account but the majority of funds are from A'20.

Anti-Racism Committee:

The ARC met on October 29, 2020. In attendance were Vivian Abraham, Jan Dumas, Karen Purcell, Mink Rosequist and Alan Wexelblat. The ARC is continuing work on Corp policy and procedure change recommendations including best practices guidelines for choosing vendors, Art Show best practices for racial justice, financial best practices in consultation with Corp treasurer and Ben Levy, and social justice + anti-racism training. The training would cost \$5k. The ARC is moving forward, next meeting in November. Folks are encouraged to attend. Check out Arisia's online calendar. We do not have proposals for the corporation at this time.

Grants Committee:

An amount up to \$5000 would be reasonable to put into the grants fund; there are 4 grants to be submitted to the Eboard for further approval and to submit to the Corporation for vote in the future.

New Business:

1. Proposed by Vivian Abraham: Arisia 2022 Town Hall

The Arisia 2022 convention committee will schedule and present a Town Hall for the greater Arisia community, date to be determined, but sometime in or around February 2021. The date for the Town Hall will be set before the Arisia 2021 convention (by the end of the January corporate meeting at the very latest). The Town Hall will take place online, preferably via Zoom webinar to allow for as many people in our community to participate as possible. Arisia, Inc. will extend our webinar license through the month of February to accomplish this, paid out of corporate funds, as the Arisia 2022 budget will not yet be passed.

The Town Hall will be publicly promoted on Arisia social media and at the Arisia 2021 convention. Information about the Town Hall will be sent via email to members of the Arisia 2021 convention. Participation in the Town Hall will be free of charge. Participation can take the form of joining in the Zoom webinar, or posting on Twitter or on the Friends of Arisia Facebook (moderators will take comments from those locations and read them aloud at the meeting).

The format of the Town Hall will be as follows: The Arisia 2022 convention committee (presently that's just me, but I hope that we will have a few more folks by February), will make a brief introduction in which we will summarize some of our plans for Arisia 2022. Everyone who attends will be given the opportunity for comment. This comment may be necessarily time limited, to make sure that everyone can be heard. Comments from Twitter and Facebook will be read aloud by a moderator. No one will speak twice before everyone present who wishes to comment has done so. Moderators will first invite those attendees who are people of color to comment, then those attendees who represent other marginalized communities within Arisia, and then everyone else.
