#### Officer and Committee Reports

#### **Eboard report:**

The Eboard voted to appoint Priscilla B, Alan W, Melissa K to the IRMC. This also requires a corporate vote. In recent years Civet (the registration system) has moved to a pricing scheme where each spring we are billed \$1 per attendee at that January's con. This makes our assignment of the spring payment to the following convention no longer correct from a budgeting point of view and we voted to assign the 2020 and 2021 payments to their respective conventions. That leaves 2020 on the hook for two payments budget wise. The payments have been made, but we think it takes a corporate vote to retroactively authorize the spring 2019 payment as not an Arisia 2020 expense. The Arisia 2019 books are closed, and we don't want to open them. We will treat the spring 2019 Civet payment as a corporate expense.

In addition, the Eboard voted to approve 1 dues waiver and discussed the issue of meeting locations going forward. At this time and due to the bylaws change voted upon by the Corporation in 2020, meetings will remain remote until further notice.

#### **COMMITTEE REPORT:**

#### Anti-Racism Report

We met to discuss our project goals for 2021-2022. We are continuing to edit the good reads account of books for our members and others to read in order to address anti-racism. We welcome suggestions and conversation about that resource. We are also in the process of finding an external consultant to review the work we've done so far and the work we need to do. This consultant would be a paid person. Once we find a person who is a good fit and is willing then we will draft a request for permission. We have lost one committee member because Alan Wexelblat has joined the IRMC and has stepped down from Anti-Racism, we look forward to his good work there.

#### Arisia 2021:

Nothing major is going on. We are working on filling positions. Onboarding is up and running and we are open to ideas and volunteers

#### **Grant committee**

Received a request for a grant from Medford Public Library. They are moving locations Sep. 2021 and are asking for grants to add Sci-fi/Fantasy content. Asking for \$5000: \$4500 for adding books and \$500 for dvds. They "would be happy to label items as purchased with Arisia Grant."

Title of project: All the Science Fiction and Fantasy at the Library

Summary of proposed project: In September 2021, the MPL will be moving into a new library building. We are asking for this grant to add lots of new and classic SF and Fantasy books to our adult collection. The new space is bigger and we will finally have a lot of room for our collections to grow. We ran out of shelf space in our old building, and as a result, the SF/Fantasy collections were limited. Instead of a mix of classic and new titles, we skewed towards new and mainstream. There was not room for classic titles or complete series or many titles from independent publishers. It was a popular collection rather than a comprehensive one.

In the new building there will be room for more- we will fill in the runs of series, stock older works of authors, purchase more diverse titles, and add classics. Our collection should be a place where users can sample what's new and read diverse voices, but also go back and read older titles that influenced the development of the genre. We want to have something for everyone. Plus all the Terry Pratchett in print.

We are asking for \$5000. While we do receive a materials allocation in funding from the city, those funds only cover new materials. This project to expand and update the collection will only be possible with grant funding. \$4500

would allow us to add between 300-400 titles to the book collection. The remaining \$500 would be used for the purchase of SF/Fantasy DVDs. Any smaller amount would also help with this project. We will be ordering new materials this summer so that when we open in October the shelves will be full of wonders. We would be delighted to put a bookplate in each title indicating that it was purchased with an ARISIA grant.

Project start date: Materials to be ordered in Summer 2021

Project end date: October 2021 (or when all items are received)

Number of individuals directly participating in/benefitting from this project: We average close to 200,000 visitors per year. We are members of the Minuteman Library Network and our items are loaned to the patrons of the forty member libraries.

Amount Requested: \$5000.00"

The Grant Committee **recommendation is that we grant them \$2500**. We will be sending a copy of this to the Corp list in order to have a vote on it at the July Corp meeting.

The idea was \$2,500 to this goal.
