Meeting called to order at 7:10pm

Eboard reports

We on-boarded Inanna. Welcome and thank you for joining us!

We met and mostly talked about things the convention needs.

As I mentioned in email, we finally heard back from the landlord and expect to sign a lease through January 2024. But the landlord has not actually gotten us the paperwork for this yet. This means we can have a corporate vote after all instead of having the eboard act on the corporation's behalf.

MOVED to renew the storage lease at \$1435 per month through January 2024.

Discussed if we downsize it will take at least two years for us to downsize our storage.

Took a vote to approve the contract for new lease - motion passed unanimously

Jan asked if it would be easier to have someone talk to the landlord, Phi said they preferred to do all communications via email to create a paper trail.

President's Report

MOVED to set the September annual meeting to 2pm Sunday September 18 via Zoom. This is really the only option given the holiday schedule, so apologies to Albacon for meeting during their weekend.

Suggested that we do an evening meeting on Sunday after the Albacon teardown. Should we start at 6 PM or 7 PM? Phi put to a vote 10 voted for 6 PM 4 people voted for 2 PM 5 people voted for 7 PM

Treasurer's Report

Phi and Jan went to OneUnited Bank on Tuesday and were able to reactivate the inactive account. We were told that to add new signatures we would have to remove people because there is a limit to the number of people allowed as signatories. The current list of signatures is Phi, Kelly, Kris, and Cate. I (Jan) need to be added to that list. People who wish to be taken off this account only have to go to the bank and request removal. This must be done in person

The check we received from the City of Boston was deposited in the OneUnited Bank account. Checks for the OneUnited Bank account have been ordered, they have not arrived. It is not a concern, because we do not yet have a need for them yet.

Plans are being made for future trips to OneUnited Bank to complete the transfer to the new Treasurer

Plans are being made to transfer all funds currently at Bank of America to OneUnited Bank

Questions for Treasurer

Rachel suggests we try to work something out with Cate. Vivian suggested we push back with the bank. Rachel will coordinate. Vivian will call the bank and suggest other methods. Phi: the bank will tell you a different thing depending on who you talk to. We could go back and see if we can get better deals. In the past just coming in full on attorney works, a notarized document might work better than getting people to come in person. Vivian and Phi will look into that. Jan is available if anyone wants to go in person.

We will also need a Convention Treasurer.

Clerk's Report

Mentors have been completed, I (Jan) needs one person or persons to review the documents, then one person to send to email list and another person to release the documents

Phi: this can be anyone on the communication committee not just someone on the eboard

Priscilla Ballou offered her services to review the Mentors, and has been voted to join the corp communication committee by unanimous decision

Arisia 2023 Con Chair Report

Jodie: just a couple things – working on staffing, meeting with the e board, reaching out to people for treasurer position, getting suggestions on people to reach out to. Trying all methods - This week doing direct emails to people to reach out. Has 16 people on a list to reach out.

Going to meet with Lisa next week. Wanted to remember what Vivian used for mass mailings to all Arisia attendees. Vivian remembered it was Mail Chimp that allowed us to send emails to people who agree that they want to get emails from us. Must send out all the information you want for the month.

Sharon: Because you are sending out this request to so many people, are you telling them other people are getting this request, are you letting them know that other people are also being offered this position.

Vivian: I don't think we have a problem with this level of staff we have now. I am sure with the number of staffing we have now if the position has been filled other positions will be available.

Vivian: Just say "we have a ton of positions available. I was thinking of you maybe for this post."

Jodie: I can do that.

Jodie: So I have been monitoring the discussions concerning social media and passwords, That is going to be on my list of things to focus on so that once I finish getting these letters out that will be my next task.

Mike S has a job description he will be posting on Monday morning. Jan can make job postings for other openings unless Jodie wants me to hold off. Jodie: Do it,

Phi: We have Mail Chimp credits that end in July.
