Executive Board Reports

The EBoard approved Bill S. as Treasurer for Arisia 2024. This is the only position that the EBoard approves that also is required to be a Corporate member. Bill has until September to attend a Corporate meeting and get voting rights.

The EBoard also looked into insurance for Directors and Officers (D&O) and got a quote. Phi talked to other groups and found that they had paid more for their insurance. Our current insurance doesn't cover as much as we thought and does not have D&O coverage. EBoard members are interested in acquiring D&O coverage not only for their own individual benefit but because not having it might be a barrier to people running for EBoard. Our by-laws allow us to indemnify officers and phi will research whether that can be done by the EBoard or if it requires a Corporate vote.

The EBoard voted to loan out box fans to Readercon and CO2 monitors to Wiscon.

The date for the August meeting was set for August 24th at 7:00 PM.

Arisia 2024 Con Chairs' Report

All Division Heads and Treasurer have been appointed. The con is looking for Area Heads. Look at the org chart; it is up to date. If you want to return for a role and haven't talked to the relevant Div Head, reach out to them. The next ConCom meeting will be on Sunday. There will be no ConCom meeting in July; the following one will be on August 17th. We're ramping up planning for the in-person part of the con, but still planning some remote activities.

The con will still have mask and vax policies. Expect to wear masks and need to have been vaccinated.

We have been working harder on marketing. Several people including etana tabled at the Watch City Steampunk Festival in Waltham and gave out all the Arisia postcards they had. Yesterday, Vivian, Melissa, and Ilene went to LadiesCon in Somerville. Many attendees there said they used to go to Arisia. Quite a few had left due to having kids, not realizing we have child care at the con. One person thought we were an anime con. Arisia volunteers took many names of people who wanted further info on the con. One person said they used to be a vendor but stopped attending Arisia and left when the con got rid of Dealers' Row. Dealers' Row is not coming back because it means that people wind up alone in a room with a stranger and that has led to some pretty bad stuff. Dealer's Row is also hard to navigate for neuroatypical folks, people with vision impairments, and service dog handlers.

The Con Chairs will be proposing a bylaws change. At the moment, all senior Con staff must be Corporate members. The Con Chairs believe that it is beneficial for staff to be Corporate members, but that senior staff should not have to pay dues or request a dues waiver and having to do so may be a barrier to people volunteering as senior staff. The proposed bylaws change will exempt senior staff from paying Corporate dues from the time they are invited to be Division Heads or Con Chairs until the end of the convention, unless they choose to do so. This may help bring in new members and potential senior staff.

Further discussion occurred regarding issues around requesting dues waivers, classism and privilege, the value of Corporate membership, solidifying people's relationships with Arisia, lowering barriers to participation, and Arisia culture.

Melissa and Ilene will formally propose the bylaws change at the next Corporate meeting.

Also there is no good transportation between our storage space and UMass Amherst. Someone can reach out to them and find out what help they need and whether it's anything we can provide. We do store other groups' items, but it's not clear that our insurance covers that.

The link for SMOFcon is available on the Arisia website. There are a number of different rates for the con. People are encouraged to book their hotel rooms. Arisia may be giving SMOFcon scholarships. COVID policies regarding vaccination and masking have not yet been decided, but will probably be based on CDC recommendations and similar to Readercon's.
