President's report:

We're just starting to get going on committees; September will be sending something out about that later on.

Eboard report:

We voted to approve Buzz Harris as the 2010 treasurer.

Vice President's report: Not present.

Treasurer's report:

We have money. Ben swept the last of the money out of the even-year account, so we now have about \$9000-\$10000 that's not allocated. The account is not actually closed, but contains seed money for 2010.

Clerk's report:

Please sign in. Dues are \$22 before the meeting and \$20 after. I signed us up for free hosting from Dreamhost, which has some interesting features like revision-control hosting and which gives freebies to nonprofits. I haven't done anything with this hosting yet.

Relaxacon report:

We are looking for someone to run Relaxacon. We've had one person put their name in, but we'd love to hear from more people.

Arisia 2009 report:

The Arisia '09 convention committee met at the Kovalcik/Mozzacato residence on October 14. The Division Heads met this past Saturday, the 25th, at the Levy/Thomas residence.

Things move apace.

We completed space planning for all convention open function rooms and the preliminary placement of some rooms which are committee only. We are in the throes of determining our Hyatt hotel comp numbers and how they will be allocated. We hope to avoid incurring money charges for hotel rooms inside the Hyatt, beyond the 25 already in the budget.

Sharon and I have gone over a preliminary ribbon order. The deadline for anyone to request ribbons is November 15. Send these requests to chair at... and I will share them with Sharon. Although you are welcome to request anything, you may not get what you asked for. We will be constrained by our budget, my preferences, and sometimes by good taste. There will be no ordering of special ribbons for a particular joke with this order.

Publications is on track to publishing books and t-shirts. We've got a draft design for the badge in process.

Program has closed brainstorming and sent off the initial emailing to prospective participants for program and events. A reminder emailing will be going out soon. Final decisions on the program and events will be in late November.

A list of Events covering early Friday evening through early afternoon Monday is in the works. We will be shutting down the Presidential Ballroom about noon on Monday for load out.

Mailings have gone out for both Dealers and the Art Show. Reservations are being taken.

The website has been updated and is (I think) a little easier to use. Everyone is encouraged to go there every couple of weeks to vote in the survey and see what's new.

Registration is now 809 total: 450 adults, 12 babysitting, 33 fast track, 6 GOH, 15 KIT, 33 Student, and 260 Comps (the rollovers and other free memberships are counted as comps in the other total)

Arisia 2009 Treasury Report:

Nothing to add beyond what's in Jill's report, except that convention registration is running ahead of last year by about 80 memberships.

Arisia 2010 Report:

I have treasurer. I am still working on lining up GoHs. I do not plan to appoint most positions until after A09, but if people are interested let me know.

Committee reports: No committees are populated.

Old business: None.

New business:

MSP (Cris, Rick, no objection) to reimburse the A09 treasurer (that is, Donald Eastlake) \$409 for three nights (out of the six) that Jill and Don were in the hotel, as their room was used for treasury and they were woken up early for it.

There is some discussion of contingency budget for ballroom lighting, but no motion was made at this time.

Vice President's Report:

Grant committee is still trying to get people to ask us for money. Apparently people think our solicitations are spam. If you know of a nonprofit that is looking for grant money, particularly if they have a project in mind, please have them send email to grants@arisia.org. Public libraries are encouraged and have been solicited to apply, but to no avail. We are also looking for another member of the Grant Committee.

Treasurer's Report:

We have money. We spent money on rent, the bulk mail permit, and some other things.

Clerk's Report:

There was no Mentor in November. There will be a Mentor in December. Please sign in on the yellow pad of paper.

Arisia 2009 Report:

Arisia '09 Division heads met here at 11 and the concom met at 2 and lots of useful work was done. The good news is that Tem has gotten some lower rate rooms and there will be a lottery. Anyone who is already on staff and already has a room reserved is welcome to join the lottery for lower rate rooms on Friday, Saturday, and Sunday to get a room rate of \$75 instead of \$123. The drawing will happen probably on December 25. There are about a dozen rooms available at this rate. This is for existing reservations as the hotel is full. Moved and passed to transfer \$2000 from the Marketing budget to the Chairman's contingency budget. Marketing has gone under budget because the college newspapers never got back to us when we tried to advertise with them.

Arisia 2010 Report:

Rick has announced his GoHs to the Staff list. Staffing continues. The Executive Board has chosen Buzz Harris as the 2010 convention treasurer, in consultation with Rick.

Committee Reports:

Noel Rosenberg will be heading up the Hotel Search committee, and Cris Shuldiner will be running the Bylaws committee. No report from either committee yet. Rick Kovalcik will be heading CIC; that's it for appointed committees.

Old Business: None.

New Business:

MSP (Jill Eastlake/Noel Rosenberg) to allocate up to \$200 to reimburse Patrick Foster to cover the expense of transporting video equipment to Arisia 2008.

MSP (Ben Levy/Jill Eastlake) to set the 2009 relaxacon rates to \$5 more than last year: that is, \$20 weekend or \$15 Friday or Saturday in advance; \$30 at the door for the weekend or \$20 for Friday or Saturday

MSP (out of A09 committee) to allocate \$800 for tech equipment to cover a PDU, a high-output video projector, additional clearcom, and equipment for broadcasting the Masq on the in-house video channel.

MSP (out of President's report) to set the March meeting to March 15, at 2pm at MIT (that is, the default time and place).

Announcements:

Boskone is coming up.

The Arisia 2009 debrief will be January 25 at 2pm at MIT.

Lunacon is coming up on the weekend of March 20-22.

Lisa Hertel is putting together a trip to the Museum of Science on January 24 at 1:00 pm.
