Officer's Reports

Eboard (Conor Walsh): We had a busy month. We loaned tech gear to NEFFA (a bin of cables), the MIT Folk Dance Club Fusion Dance (lights), and BIDA (lights), and Balticon may want to borrow some stuff. We loaned a credit card machine to CostumeCon. Anna got a corporate credit card to charge things (for

the conchair's discretionary fund). Convention Master asked for Zambia information; we gave most but not all of it, and we need to seek an NDA with them. In the end, they didn't actually need the info. DDA renewed arisia.club; we gave him info on how to turn it over to the corporation (which will pay for it). On April 26th, we interviewed the two chair candidates, and after much discussion IRL and via Google Hangout, we **moved to select Jaime as chair of A18.** The corporation needs to confirm this. PeterO asked whether the fact that Jaime was already ACC had influence; in general, not necessarily. Conor notes that being highly involved in Arisia is a factor in general. **MSPU**. Jaime says, "Thanks, guys."

We discussed a number of incident reports. We need a better way to inform people of where in the process their IR is, and send out regular (monthly) updates. We also need to set the expectation that IRs will take months to settle. We now send an email affirming receipt of the IR, but need to be better about contact after that. These things are hard, and we need to take our time to get it right, and we have to be better at communicating that. What about registration refunds if people don't like the outcome? We would do it if asked, but don't want to offer that in advance. Phi suggests a future blanket refund policy (for any reason).

- 1. After incidents at A15 and A16, one person will not be able to volunteer in a position of authority (i.e., area head or higher) for A17. That person will need to avoid another member (including making eye contact), and spaces that member may be in, with whom they had a negative interaction, next year. Further action may be taken, depending on behavior.
- 2. A person in charge of a group was informed on how to register parties and create events. No other action will be taken at this time.
- 3. A one-year attendance ban was issued for online harassment.
- 4. There was smoking in a room; the person whose room it was apologized, as they were unable to attend for health reasons and were not in control; they will not be having those people in their room again. They are aware of the hotel's smoking policies. No further action was taken.

Some people asked to see their own incident reports; we determined the bylaws don't allow us to release the full text. However, we deemed that a person could see their own text (sometimes it's dictated). Knowing that people might see their own text will change the form; Ops is working on this.

The eboard looked at the contract for the Vernon (A17) book. It still has to go to the author and NESFA Press for approval. It's noted that the eboard can make suggestions, but doesn't actually get a say. The only comments came from Lisa, who spent three years looking at NESFA Press contracts when she was on their eboard.

President (Conor Walsh): There are people who want to help look for a new Relaxacon venue. Ben notes they are not officially a part of Arisia, but they are free to call around and investigate. Rachel Silber suggests they coordinate with the hotel search committee (make it a subcommittee). Terry Holt and Conor signed the last of the Student Writing Contest certificates and they went out. Noting that complex systems run in degraded mode, Conor supports the president filling eboard vacancies, because it's fastest, and because temporarily filling a seat may be a problem.

Vice President (Jaime Garmendia): No report.

Treasurer (Ben Levy): As usual, we have money. If you have questions, see the report in *Mentor* (below), or ask Ben.

Clerk (Lisa Hertel): Sign in; it's \$8 to join now or \$6 after the meeting. Conor said that Lisa has been an awesome clerk; she says NESFA trained her well.

At Large (Daniel Eareckson, Abby Noyce, Jaelen Rachlin): No report.

Committee Reports

A16 (Nchanter): Absent.

A16 treasurer (Rick Kovalcik): Submit your expense reports by the end of June. He hopes to close the books before the annual meeting.

A17 (Anna Bradley): We are going to have a con reasonably soon. There is a June 12th division head meeting. We just had a meeting about communications (print, web, social media) in an open format, and brainstorming happened. On Saturday, June 11th, there will be a Staff Services Social Gaming Night from 6:30pm-10pm at Pandemonium Books & Games in Central Square, Cambridge. This is free. RSVP so we can buy enough food, but it's okay if you just show up; feel free to bring a game (Pandemonium has a play library). On June 26th, there will be a program brainstorming meeting at 2pm at the Westin.

A17 treasurer (Tom Traina): We have a budget. It was sent to the div-head list, and will be discussed at the next div-head meeting.

A18 (Jaime Garmendia): He's looking for a treasurer.

Budget (Ben Levy): We have a corporate budget (below) to be voted on for the June meeting.

CIC (Rick Kovalcik): When stuff goes out, it should come back to storage *within a week*. People who borrow things should indicate when they will be returned. We should make this clearer to borrowers.

Grants (Jaime Garmendia): *Locus* thanked us for their grant. We still have an outstanding \$1000 grant that needs more information, and a preliminary one from the Cambridge Public Library.

Honors (Fred Isaacs, absent): We should send condolence cards to two members. We charged three people to make that happen.

Hotel search (Phi): We plan getting an overflow contract for aloft & the Marriott Renaissance in June; we will not be able to get one for Element. (Element is more expensive, but has kitchenettes.)

IT (Abby Noyce): Mailing lists are moved, and we are moving Convention Master (CM). Dan Franklin is delegated to do this, and there are technical issues. PeterO says it has put Zambia behind schedule (because they interface). Reg is also anxious to get it going. Unfortunately, Jaelen says Convention Master's servers are not reliable, though we can access them. Noel says our stuff is too new, but he has backed up the machine and recreated a new one. He needs access (Ben can grant it). They will talk. Anna asks for a timeline; Noel says the server and CM should be this week or next; he's not sure about the data portability with the version changes. Jaelen says we have a copy of the data backed up. There have been a few changes since the last backup, and he will make a new copy (sans dates of birth). We want to be on CM9. Zambia and Reg are coordinating with Convention Master.

The IT needs to consider turning spam filtering back on, which causes mailing list delays with Dreamhost, but reduces spam. All out aliases go through Dreamhost. Conor says spam is evil.

Logo (Anna Bradley): Anna talked to Lee Moyer, but hasn't done much else. Lee is currently working on the Arisia website and generated a convention logo, which may be up by Relaxacon.

Long Range Planning (Conor Walsh): No report, though we were amused by PeterO's cruise ship idea, especially considering global warming.

Relaxacon (Rick Kovalcik): Nchanter had to step down; Kris Pelletier will be taking over. She is coordinating on food. It's in two weeks, please come.

Student Art (Jacob Lefton): He needs to step down and will be happy to mentor his replacement.

Student Writing (Conor for Terry Holt): All the certificates went out.

Old Business

Bylaws Amendment: Replacement of Officers: Rick Kovalcik feels we should codify having one of the members-at-large fill in for a vacant office until an election can be held. He moves to merge 3.8 and 3.9. In the old days, having one person having the power to replace an officer was reasonable, but in these modern, internet days, there's no reason the entire eboard can't handle it. Using a member-at-large makes sense, especially if there are IRs to handle. It's noted the member-at-large still only has one eboard vote, even if saddled with two offices.

For reference the current wording:

3.2 The duties of the [VP] officer are as follows: ...

(b) The vice president shall assume the duties of the president during any vacancy in the office of the president and during the president's absence or inability to act. The vice president shall insure that corporate activities are in accordance with federal, state, and local laws. The vice president chairs the Grant Committee. ...

3.3 Only one person can hold any office at any given time. No person can hold more than one office at the same time. The person approved as convention chairperson for a specified convention may not run for an office until after that convention. ...

3.8 Whenever any office (including president) becomes vacant, an election shall be held as soon as possible to fill the vacancy. Nominations shall be in accordance with Section 3.4. An officer elected to fill a vacancy shall take office immediately. Pending an election, the president shall fill a vacant office by appointment.

3.9 Whenever both the offices of president and vice president are vacant, the remaining members of the Executive Board shall appoint one of themselves or another General member to act as president until the vacancy can be filled by election.

Moved to amend the bylaws to merge 3.8 and 3.9 and renumber as necessary to:

3.8 Whenever any office (including president) becomes vacant, an election shall be held as soon as possible to fill the vacancy. Nominations shall be in accordance with Section 3.4. An officer elected to fill a vacancy shall take office immediately. Pending an election,

the president Eboard shall fill a vacant office of vice president, treasurer, or clerk by appointment, preferably from among one of the current members-at-large. When the office of president is vacant and the vice president has assumed the duties of president as per bylaw 3.2(b), the Eboard would temporarily fill the office of vice president *in the same way* pending the election for president. When an office of member-at-large is vacant, that office remains vacant pending the special election. Section 3.3 does not apply when a member-at-large temporarily fills an Eboard vacancy.

The eboard picks someone, with a preference for an at-large member, but it doesn't have to be one. Online, Rob Bazemore points out that it is only the *duties*, not the *office*, which are assumed by the VP; an election is held as soon as possible. Conor asks about committee conflicts, such as Budget (7.1, 8.1); Abby feels that you would also get the committees when you assume the office. Originally, as a check on power, certain officers could not serve on certain committees. Lisa asks if assuming the duties instead will fix this? PeterO asked about conchair replacement; it's noted that is a different part of the bylaws (which only deals with removal). Tom Traina suggests an amendment to let people resign in advance, but that was deemed a different motion. It's obvious this needs further crafting and discussion. Rick Kovalcik **moves to table**, and give the eboard a chance to work on the wording. **Motion to table passes unanimously**.

Son of Arisia: From March's LRP, Conor moved that it is the sense of the corporation that if a small number of staffers come to us proposing a convention, that we would be open to them running it. This was tabled meeting before last. Lisa moves to take it off the table; Rick Katze seconds. Rick Kovalcik thinks this is a Good Thing. Conor says, for example, someone pitching the Indie Game Expo (which we folded into Arisia, but could be its own thing). It does not commit us to actually running it; is the wording too vague? Rachel asks if this only relates to conventions? Joel Herda thinks the corporation would normally do this. Anna says this was asked on the survey, because people believe Arisia "doesn't do that." Noel reminds us that a gaming convention was proposed in 1996 (it never happened). Sharon is unclear on the process—who makes the decision? Abby thinks the current process still exists—bring a motion to the corporation. (This is how Relaxacon started.) Lisa suggests amending "running it" to "hearing their proposal." MSPU. Abby moves to change "convention" to "convention or other event". MSPU. Thus, it is the sense of the corporation that if a small number of staffers come to us proposing a convention or other event, that the corporation would be open to hearing their proposal. Ben asks where it goes in the policies; Rick Kovalcik says at the end of convention policies. Conor rules it is just in Mentor, not a policy. MSPU.

New Business

Art Show Capital Expenses (Phi):

- New pipe feet that will make the pipe stack better on their carts: \$70.70
- More podium ladders to match the ones we got last year: \$160
- New drape to hang below the panels (faster to put up than the hotel tablecloths we've been using, and not subject to the hotel's whims of tablecloth color): \$478.38 for the fabric plus probably \$40 in shipping and another \$40 in sewing supplies for NoeL (IFR—inherently fire resistant)
- More velcro ties for electrical cable management, \$25
- Parts to repair broken lighting strands, \$25-\$50
- 20 10' black extension cords: 17 to cut up as part of lighting strand reconfiguration, and 3 more to use for circuiting, \$200
- Sample light strand parts to evaluate for possible future upgrade, \$75-\$150 (make them less floppy)
- Hand tools (we need two pairs of channel-lock pliers, and probably need a few other things too), \$50-\$75
- Clock for the office, \$4
- Two good handheld magnifiers for general lending for access, \$25 each
- More 3-part-form NCR paper, about \$160/case (10 year supply)

Grand total is between \$1378.08 and \$1503.08; while the eboard probably could do this, it's better to bring it to corp. **Moved to appropriate \$1500 from the capital funds to cover art show capital expenses**. Moved by Phi, seconded by many. Noel asked about storage; Phi says there is room in the art show totes and rolling cases. Noel also asked about storing the paper for 10 years; it doesn't do well over time. Phi admits that is true, but the staff mostly uses it and has been instructed to use a ball point pen and press down hard. Alex points out we can throw it out if it stops working. Ben asks if \$1500 is enough? Phi thinks yes, as he won't spend the top amount on everything. **MSPU**.

Relaxacon 2017 Venue: Rick **moves to be allowed to negotiate Relaxacon 2017 in the same venue**, given similar terms. While he would like an accessible place, it hasn't happened in the past, and the

current place works for many people. This way we can have a careful search for 2018. **Passes**, many to one. If you are interested in searching for a new venue, email the eboard.

Future Meeting Dates: Moved to set the August meeting to Thursday, August 25th at 7:30pm. Rick Kovalcik questions whether we need an August meeting; Conor can't do Thursdays. Abby moves for **Tuesday, August 30th, at 7:30pm** at NESFA if possible [confirmed]. **MSPU**. **Moved to set the September meeting to September 18th at 2pm** (the traditional date/time) **at the hotel** (*not MIT*). Sharon moves, Joel seconds. **MSPU**. We vote on the location (probably Stone); **MSPU** also.
