President's Report

The Lawsuit is looking like it will be dismissed. Our Lawyer is filling a motion for this action.

The Park Plaza has accepted the demands made on the last round of hotel contract negotiations. They are sending us a contract and we hope to have it signed very soon. This does not necessarily included the corkage demand.

Some discussion was then held informally upon the possibility of speeding up the hotel contract process and as to the possibility of a multi-year contract.

The president discussed the recent application of the Ratcliffe people.

The application asked for Arisia to accept a stock pile of books from an individual and then turn the books over to Ratcliffe so that the individual donating the materials could claim the donation as a tax deduction.

It was the president's descision to recommend that the individual donate the books to Arisia. Arisia would then house the books in the Ratcliffe facility with the express understanding that any Arisian might also be allowed to access the materials. Finally, after a period of approximately 1 year, Arisia would grant Ratcliffe the books.

Some discussion was held as to the presidents descision and as to the possible valuation of the books.

Treasurer's Report

Budget Committee

[The Budget committee (minus the Treasurer) informally met to set a date for the next committee meeting at the behest of the president.]

The next meeting will be held July 5, 1996, with the time and location to be announced.

Corporate membership fees were set for \$6 before the corporate meeting and will be \$4 after the meeting.

A copy of the convention/corporate polices was distributed to all members attending the Corporate meeting. These policies will be ratified by the corporation at the corporate meeting.

Arisia 1996

The books for the convention are now complete, and the convention account has been closed and remaining funds transfered to the corporation. Accounts receiveable in the amount of \$448.40 remain outstanding. All other business has been completed. The net income for the convention, including the accounts receivable, was \$8,268.26, against a budgeted net of \$8399.00.

MOVED to disolve the Arisia 1996 convention committee and transfer any remaining business to the executive board. Motion PASSED with one abstention.

It was decided that the idea of an office space has merit. It was recommended that information as to possible locations be forwarded to the Eboard for consideration.

The Eboard announced that it was time to begin thinking about running for a corporate officer vacancy. Nominations are now being accepted.

A Convention Chair for the Arisia 1998 convention is still needed. The Eboard is still accepting applications from interested canidates.

The meeting was adjourned at 9:16 pm.
