June 2013 Meeting Minutes

Date, Time and Place: Meeting called to order by Rick Kovalcik at 3:43pm at MIT building 66.

Corrections to the minutes: none.

Eboard (Rick Kovalcik): Has anyone here done any research into alternative venues for relaxacon? No. Based on the lack of other alternatives, and on getting the same terms (room rates, no charge for the house and no room rental minimum), MP many-1 to authorize Rick Kovalcik to finalize an agreement with the Corsair and Cross Rip for next year's Relaxacon.

We picked up a donated freezer and are in the process of picking up another donated freezer. Not all of the freezers will necessarily come to con.

President (Rick Kovalcik): Sorry I was late. It's hot out there.

VP (Conor Walsh): It's really hot. There's ice and cups.

Treasurer (Ben Levy): We have a corporate budget to talk about. *Corporate budget passes many-1 with two abstentions.* We expect to start with the audit of the A12 books once the

budgets are both approved. We'll try to finish it by the end of August. We're not sure when was the last time we did an audit.

Clerk: no report.

A13: no report.

A13 Treasury: no report.

A14 (**Lisa Hertel**): We're still negotiating with PSAV over the truss. Sharon is stepping down as assistant chair to take over as head of Events. We have a budget.

A14 Treasury (Rachel Kadel-Garcia): We have a budget. We would like to make two amendments to the budget as published: under Exhibits amend Art Show admin from \$150 to \$250, and under Member Services amend Promotions admin from \$25 to \$80. The new bottom line is \$1177. Amendments pass unanimously. MSP (D'Antonio, Boyle) to amend Art Show income from \$3500 to \$3200. Some moneysaving suggestions are brought up but no motion is made. A14 budget passes 26-0.

CIC (Rick Kovalcik): We have gotten the radios back from Big Apple Ponycon and are inventorying them. I put the extra A13 publications on top of the balcony. Skip suggested some new totes. The eboard has asked for more information. We think these are opaque flip top totes, which are good in the cold but bad in the wet. If you think you need new totes, send mail to CIC about what you need. We have a volunteer (Craig McDonough) who is willing to inventory storage after Worldcon and wants a key, and Anna needs a key, and Craig McDonough has also volunteered to record load-in and load-out procedures. We need to update the CIC committee list in Mentor.

Grants: There are no outstanding grant requests.

Honors: No report.

Hotel Search (Noel Rosenberg): The Boston Park Plaza has been sold again, to the owners of the Marriott Long Wharf and other hotels. Donald Saunders, who was still a minor investor after the previous sale, is no longer an investor.

Comps: No report.

IT (**Noel Rosenberg**): Ben and I have been working with the Zambia folks to get them up and running. hobbit is willing to help out in various ways.

LRP (Nicholas Shectman): We tried to schedule a meeting at the beginning of the month but didn't succeed in actually meeting. We will be trying again with a Doodle Poll in the next few weeks.

Meeting Search (Bridget Boyle): We published a survey. Every current and past corporate member is encouraged to respond. Please respond based on your own personal needs. There is some discussion about where else to send the survey besides the corporate mailing list.

Relaxacon (Rick Kovalcik): Abby is willing to do food again next year. If you're interested in doing food, helping with food, or chairing the whole shebang please contact Rick. This year's relaxacon made about \$150.

Student Art Contest: Jacob Lefton will be doing SAC again next year.

Old business: Has there been any forward progress on the scholarship fund? There have been no donations. The corporation has set aside \$200 in matching funds, and the eboard was authorized to administer the funds. The idea was that this would be for general attendees and that the amount of money wasn't likely to be enough to cover much more than memberships. The last we spoke with Victor, he and Eugene were thinking of going off and doing a scholarship fund separately, and if they do we would publicize that. It would be useful to publicize the match. But we should have some consensus on what this fund is actually for. The eboard will consider this and report back.

New Business: Is there a committee for the student writing contest? Not currently. This is waiting for a head. Terry Holt volunteers to run it. *Rick appoints Terry Holt to the Student Writing Committee (and this is approved unanimously).*

MSPU (Conor, chorus) to allocate \$100 to give to Camelot as a thank you for use of their kitchen for A13, and \$100 to give to Mosaic as a thank you for the use of their kitchen in A12. There are two abstentions.

Announcements: Sunday July 21 at 2pm is the corporate meeting and barbecue at Rick Kovalcik's house. The July 28 concom date published in Mentor is incorrect; that meeting will be Sunday July 21 at 4pm.

Tuesday August 13 at 7:30pm there will be a corporate meeting, probably at NESFA.

Sunday September 8 at 1pm at the hotel there will be a concom meeting.

Sunday September 15 at 2pm there will be the annual corporate meeting at MIT.

M (Dumas, D'Antonio) to move the annual meeting from the 15th to the 22nd. M (Kovalcik, friendly) to amend to the 29th. Main motion PASSES.

October 20 there will be a concom meeting at the hotel. November and December meetings are currently also scheduled to be Sundays at the hotel. The January concom meeting will be on a Sunday at the hotel.

NESFA will be holding a picnic next Sunday at the Lars Anderson Park in Brookline. Please come and eat NESFA's food and drink Arisia's leftover soft drinks from Relaxacon.

Nauticon will be September 13-15 in Provincetown. 21+.

Gaylaxicon is coming back to Boston in 2014. It will be July 3-6, 2014. We are in final hotel negotiations now and are looking for volunteers.

July 11-14, 2013 is Readercon in Burlington, MA. Thursday is free to attend.

July 12-14, 2013 is Connecticon.

Conor sent out a document to staff-discuss about food procedures. This is about how we tend to do things and not just A14, so there might eventually be motions out of this. If this is something you care about please go take a look.
