Executive Board Report

The Eboard was asked for vote on an incident report by the IRMC on March 13th

We have opened nominations for A25 Con Chairs. I am happy to help coordinate people who are interested in being part of a Con Chair team.

Arisia 2024 is our last year under the current contract with Westin. We signed this as part of the settlement that we made after moving hotels during the strike. There are reasons to stay with the Westin: they are super accessible for starters. When we signed the contract there weren't a lot of hotels that could handle a convention of our size, but now there are, so a completed contract is in our interest.

Vivian and Rebecca volunteered to be on the Hotel Search Committee

Motion made to start the Hotel Search Committee by Phi. Rick seconded the motion. The motion passed unanimously.

Motion made to set the June Corporate meeting for Tuesday, June 13th at 7 pm. Motion passes with a majority

President's Report

We got a large grant from the Mass Cultural Council and an additional \$2,000 from the DC Worldcon. If we get the festival grant we could get close to 30,000 in total grant money. The grant money is largely unrestricted and can be carried forward to Arisia 2024.

Rick: Do you want to say something about storage being sold?

Phi: The building is being sold to Historic New England, and we are told that they are interested in keeping current tenants around. The current landlord considers an email from us to be a lease (and if they didn't they would owe us triple damages for not returning the security deposit). Keeping us as tenants would exempt Historic New England from property tax on the space because they and we are both nonprofits, so I am hoping that they see it as in their best interest to keep us as tenants

Treasurer's Report

Almost done with A23 treasury. One last thing that I have not resolved: There is a print that did not go home with the artist after the Art Show, but we don't have a record of who bought it either. We don't need to report the buyer to the artist for a print, but we do need to know whether we owe sales tax on it. As we balance the cash boxes and check the tags we get back at checkout, we might find that it was sold and not recorded, or that it wasn't sold. I should have this figured out by April 15. The difference is 63 cents that we might or might not owe to the state.

The budget on the staff wiki shows our bottom line. We had income larger than predicted. We predicted printing the pocket program, but we did that at NESFA and rolled it into another budget line. We also didn't do Anime/Video or some other things. All told A23 ran a surplus of about \$25,000. Usually, I'd consider such a large surplus to have been a lost opportunity for the con to have been better, but this time I don't think we had the people points.

Arisia 2024 Convention Report

We have assembled the Con Chair team - Melissa and Ilene as Co-Chairs, Gail as Assistant Con Chair, Dale as Senior Staff Mentor and Julia as Meeting Scribe and Administrative Assistant.

Many Division Heads are already in place. We have a Treasurer. We probably have someone for Hotel. We are currently looking for leads for Events, GOH Liaison, Safety, and Publications.

We have 3 Guests of Honor - Ryka Aoki as Author GOH, Winona Nelson as Artist GOH, and Tanya DePass as Fan GOH.

We have learned that we do not need to be so tight with money this year thanks to grants and a surplus from last year. Access has big plans that we can fund and we are also looking at having several featured guests who will have their travel partially covered.

The Arisia community town hall is on April 2 at 1:30 pm and is open to all Arisians. We hope to have a second Town Hall in September. The next Con Comm meeting is on April 23 at 3 pm.

Committee Reports

Anti Racism Committee

Vivian attended the regional workshop last week on DEI diversity equity at smaller organizations where there were people from schools that attended. One of the things that they said was helpful. not all these things were helpful for Arisia but some of those things might be. I will put it up on Slack after the process. It was nice to know that not just us hit a wall where we do nice things and then kind of wonder what is next

Incident Review and Management Committee

Current status of incident reports:

- Three reports from Arisia 2020, four reports from Arisia 2021, twenty-four reports from Arisia 2023, including reports received before and after the con that we bundled with A23.
- We sent two reports to the Eboard for voting. One of them has been voted on, and the Eboard requested further information concerning the other, which the IRMC is in the process of gathering.

Actions taken by the IRMC and the Eboard:

Several reports were made at Arisia 2020 concerning an attendee that had been argumentative and disruptive during a panel. At the convention, this person was given a warning to refrain from this conduct in the future. The IRMC recommended that the action to warn be confirmed, and no further action be taken. The Eboard has voted to accept this recommendation.

Questions:

E.J. Barnes: What do you mean by 'Eboard votes to confirm'?

Vivian: Sometimes the Eboard will vote to censure or pull a badge or something we review and decide that something has to be done or not. We decided that an action was taken and that the action was appropriate.

E J. Barnes: So do you warn them again?

Vivian: Sometimes we decide they might need to be warned again, but not always. The IRMC is always looking for other people to help with the IRMC.

Phi: Our practice does not pose a problem for most things but, our policy does have a place (for decisions) to be overturned. This would be the place to mention this.

No motion to overturn was made. No further questions.
