Treasurer's Report:

1. Three and a half years ago, our Anti-Racism Committee recommended that the Arisia corporation move our bank accounts and credit card to Black-owned banks. We opened a new bank account at OneUnited bank shortly after that and let our Bank of America credit cards expire. It took some time to ensure that all of our finances were moved over to the new bank accounts so that the old ones could be closed, and to find a suitable credit card issuer for our needs. As of this month these processes are complete. The old Bank of America bank accounts are now closed and we have a new credit card from M&F Bank, suitable for transactions that place a hold on the account, such as renting trucks.

2. Arisia owns a copy of a not-for-profit generally accepted accounting principles (GAAP) accounting manual, and phi was looking through it recently to see where we needed to update our practices. One surprise he found was that when we authorize expenses outside of a budget, those authorizations do not expire at the end of a fiscal year, but remain in place indefinitely. If we only spend part of the money, the remaining part should be reserved until it is either spent or revoked. The recommended course of action is to review the outstanding authorizations at the end of each fiscal year and bring the authorizing body a list of which ones to keep. In our case the authorizing body is the corporation.

phi doesn't know how to figure out which unspent authorizations might be in effect under these rules. Fortunately he doesn't have to list the ones we're sunsetting, only the ones we're keeping. If there are any authorizations we decide we want to re-make we can always do that. He believes that our ongoing authorizations, such as rent, are now all included in a budget, so they will not be affected.

This is the first corporate meeting after the end of the FY23-24 fiscal year. Therefore phi moved that none of the unspent non-budgetary authorizations from previous fiscal years should continue in effect. The motion was seconded and passed via voice vote.

3. Now that we are in a new fiscal year, the last remaining vendor deposit (with the UPS store) can be applied to our mailbox fee for this year. This simplifies our financial report, and phi has made a few simplifying or clarifying format changes as well.

The A25 and FY24-25 corporate reserved funds are intended to show how much money we need to set aside to wind up with no further shortfall in available funds because of those activities. Until A25 has a budget, phi is using their income numbers as an approximation for this impact. In other words, the presumption, for now, is that A25 income is for A25 to spend and that it will do so.
